WELCOME

APPROVAL OF MINUTES

BOARD MEMBER'S REPORT

Mrs. Chris Patricca shared throughout the presentation regarding House Bill 7069.

PRESENTATION BY ATTORNEY ROBERT DODIG

Mr. Robert Dodig gave the committee an update on House Bill 7069, with the following information:

- Our School Board voted 7-0 to participate in a lawsuit with 12 other school districts in Florida. The Lee County School District will be one of the plaintiff's in the lawsuit against the Florida Department of Education, the Commissioner of Education, and the Chair of the State Board of Education. The lawsuit centers around 6 specific provisions. All of those provisions speak to the local authority of an elected school board in Florida.
 - 1. Sharing of capital funding with Charter Schools
 - 2. Local education agencies will compete for federal funds
 - 3. Requirement of state created contracts with Charter Schools
 - 4. Development of Schools of Hope
 - 5. Sharing of Title I dollars with Charter Schools
 - 6. Use of Turn-Around Schools reassign students to another school; contract with an outside entity; close the school.

- The counties that are participating in the lawsuit are: Alachua, Bay, Broward, Clay, Duval, Hamilton, Orange, Pinellas, Polk, St. Lucie, Volusia, and Wakulla.
- The suit is filed in Leon Circuit Court, which is the seat of government.
- A parallel matter was filed in the Florida Supreme Court, alleging the legislature violated the constitution.

FAC UPDATES

Mrs. Kelly Letcher updated the committee on past FAC recommendations:

- Naming Rights Dunbar High School will be the first school to use the Naming Rights process.
- Efficiency Study/Operational Audit The District is working with Gibson Consulting Group, the firm that is handling the Efficiency Study, by providing them with necessary information. The firm will be coming to the District offices during the week of January 29th.
- Sales Tax The District is working through the process of collecting in-depth information. During the meeting, a member asked a question regarding an outside group working on the sales tax issue. Mrs. Patricca responded, "It is inappropriate for the committee to discuss that in the Finance Advisory Committee meeting."
- Hurricane Irma update The cost to the District from Hurricane Irma has amounted to 23 million. The District has hired Adjusters International to make sure that the District receives the correct insurance reimbursement and accurate dollars from FEMA. The total breakdown of reimbursement to the District will be 75% FEMA, 12.5% state insurance and 12.5% lose to the District.
