Call to Order/Welcome

Chairman Scott Hertz welcomed committee members and called the meeting to order at 5:31 p.m.

Review of DAC Executive Committee Meeting Minutes

Chairman Hertz asked for a review and approval of the February 4, 2019 meeting minutes. The minutes were reviewed by the committee. Andy Erickson made a motion to approve the minutes, as amended, which was seconded by Cedric Hall. All in favor, the motion carried.

New Business

Chairman Hertz discussed the February 25, 2019 School Board Advisory Chairs' meeting, during which the chairs each shared their quarterly reports with Dr. Adkins, Superintendent. The School Board Advisory Chairs will share their quarterly reports with the School Board on March 12, 2019.

Chairman Hertz introduced Dr. Denise Carlin, Executive Director, Strategic Planning and Community Engagement and District Advisory Committee Staff Liaison. Dr. Carlin brought forth

a recommendation to move the Inclusion presentation to April, 2019 and to host a presentation on Legislative Priorities during the March, 2019 meeting. The purpose would be to inform, provide input, and make a call for action. The committee discussed the recommendation.

Cedric Hall made a motion to have a presentation on Legislative Priorities for the March, 2019 District Advisory Committee Meeting. The Inclusion and Title I Subcommittee presentation will move to April, 2019 and the Office of Diversity and Inclusion and Superintendent's Year End Review will remain the topics for the May, 2019 meeting. The Student Assignment (Long Range Plan) will move to fall, 2019. The motion was seconded by Stephanie Chervoni. Casey McConnell would like to have an update on curriculum and the textbook adoption process. The committee discussed Ms. McConnell's request, and came to a consensus to hold off until more information comes from the state. All in favor, motion carried.

Chairman Hertz asked the committee if there should still be breakout groups during the March, 2019 meeting. The committee discussed the recommendation.

Cedric Hall made a motion to not have breakout sessions during the March, 2019 meeting. The motion was seconded by Casey McConnell. All in favor, motion carried.

Chairman Hertz will remind all District Advisory Committee members at the March 14th meeting to ask questions that affect multiple groups of students and/or families, and to save personal questions for the breakout sessions or comment cards.
