Welcome and Introduction of Members

The meeting was called to order by Ken Weaver at 6:00pm. The chairperson welcomed all committee members, new members, and guests. An informal introduction was made by each committee member.

Board Member Report

Ms. Vaughn comments-

If you keep up with the school board calendar- I just want to remind everyone that tomorrow at the school board room on there will be a Town Hall Meeting at 6:00pm on "Walking and Bus Stop Safety".

As you know that this has been a huge issue lately in Cape Coral, the community has started committees, rotary and neighborhood groups have become very active. We have other communities that I am concerned about that have need besides the Cape. Only 9% of the Cape Coral have sidewalks. In areas like Lehigh Acres, I would say it is a huge issue and I understand that there are some areas in North Fort Myers too. This is not just a Cape Coral issue. All of this has come forward since the tragic death of the hit and run. We have communities like Sanibel, the Village of Estero and Bonita Springs that are very involved with the schools. Again, they have that infrastructure and we have areas that do not. We have a workshop on the 17th by state law, the statute says July 1st that we have an auditor that reports directly to the board. I am in shock that we don't have a bigger auditing staff but an internal auditor here that does a lot of work with the individual schools looking at their books, Robert Brown, but that is an important decision that the school board will be making, and we will be discussing options at the workshop, but we cannot vote at the workshop.

Also, Rob Dodig, staff attorney who became board attorney is leaving the school district and there will be two huge positions to fill.

Update in Tallahassee- Any legislation decision that are going to impact our curriculum-

Dr. Quisenberry responded-

They sent out a survey to determine whether there should be a standard change or not (should the standards stay the same, be modified or deleted by giving a 50-word response explaining why it should be modified or deleted). Everybody should have a voice especially instructional staff as to what is happening at the schools and the standards.
