- 3) Construction purchasing requirements Invite Procurement department to explain the RFQ process in detail ½ hour for Procurement and ½ hour for committee to make comments. Would like to see a review of the RFQ process to recognize the flaws in the system, local participation issues and unfair weighted questions in the scoring process. Discuss a recommendation to the Board for Procurement to look at a different approach in the RFQ process, possibly sponsoring another public forum.
- 4) School construction updates, construction standards and cost of construction (including kitchen work, if needed)
- 5) Invite Planning department to give update on future projects 5 years out
- 6) CAC to be included in the sales tax initiative. Leeschools.net has the expenditure plan online by school. Meeting dates are also published so members could go to listen to decisions made. Pat to send out link.

Mrs. Giovannelli would like to see the CAC membership submit a recommendation to the Board for Procurement to look at a different approach for the RFQ process based on the statute regarding local contractors.
