Review of Minutes: The minutes were read and approved. Motion was made by Kelly Lavis to accept the minutes with a second by Mary Stead.

Administrative Update: TOMS is gearing up for the upcoming Florida Standards Assessment (FSA). Students will be completing an infrastructure trial test in a few days. This is a practice test that is used to test that the system is working properly when everyone is logged on at one time.

TOMS held a fantastic Student Assignment Open House on January 18th. There was an excellent turn out with some parents parking across the street and walking to the school. While the event was very crowded, overall parents were very pleased with the open house set up and rotations.

Beginning the third quarter Three Oaks Middle School implemented the use of the CASTLE student hall pass. Teachers and administrators are now better able to monitor how long a student is out of the classroom. Next year, students and parents will be able to use the CASTLE program to view the student discipline record and grades.

The second quarter honor roll will be held on Tuesday, February 7th at 2:15 p.m. for eighth grade students. Sixth and seventh grade honor roll will held be on February 8th, with sixth grade at 10:00 a.m. and seventh grade at 11:05 a.m.

School Improvement Plan Mid-Year Review: Mrs. Moore presented information about the School Improvement Plan mid-year review. The school improvement plan is a living document and changes can be made based on student test data at this point in the school year. Mrs. Moore will be meeting with the school administration and leadership team to review student academic progress for this school year and to determine if any of the school goals need to be adjusted.

District Advisory Council (DAC) Report: Mrs. Lavis presented the DAC report. She shared information about the upcoming Education Forum scheduled for February 8, 2017. The Forum will be held at the Cypress Lake High School Auditorium from 6:00 p.m. until 8:15 p.m. The topics that will be discussed during the Education Forum are Student Assignment, COMPASS Learning Paths, Career Academies, Graduation Requirements, and Getting Ready for College.

Dr. Ami Desamours, Chief Financial Officer, shared a PowerPoint presentation. Highlights included school growth and impact, utilization rates, needed projects, capital funding and shortfall, as well as innovative ways to raise additional funds needed by the District. DAC members made a motion that the school board revisit the half cent sales tax proposal.
