Kelly Letcher welcomed everyone to the meeting at 4:01 p.m.

APPROVAL OF MINUTES

BOARD MEMBER'S REPORT

Debbie Jordan began by stating that the District is focusing on the opening of the schools. And with teachers beginning on the 18th of August, she was able to see a Home Connect Session in action. She pointed out how well the teacher was able to keep the kindergarteners on target.

She will be meeting with the Grants Department this week and was excited to share that the District will be receiving double the amount of grant funding than in past years. The CARES Act for the Elementary and Secondary School Emergency Relief Fund (ESSER Fund), will provide emergency relief funds to aid the District with the impact from COVID-19.

At this time, there are still approximately 7,000 students whose parents that have not yet chosen the type of instruction for their child(ren). She then added that the Lee Virtual choice has been the most popular.

Kelly Letcher added to Ms. Jordan's information regarding the additional funding. She explained that the Cares Act has multiple pieces.
