Daryl Teblum welcomed everyone to the meeting at 4:02 p.m.

APPROVAL OF MINUTES

The October minutes were approved unanimously.

BOARD MEMBER'S REPORT

Mrs. Jordan shared with the committee that the District signed an MoU with Lee Health, in order to starting COVID testing at the school. The actual rapid test is done by Lee Health and not school district staff. Also, the testing is paid for by the Counties CARES Act funds.

DISCUSSION RE SALES TAX-SARAH COX, COORDINATION-BUSINESS SERVICES

Sarah Cox began by explaining that in November 2018, the voters passed a referendum for a ½ cent sales tax increase due to the need for additional capital funds. The District was experiencing a decline in capital funds and an increase in student enrollment.

With the estimated amount of the Sales Tax Budget being \$144,345,409 or 32% of the capital budget, the following is a listing of the project these funds will provide:

Original projections were revised in early September to better align with the state of the economy and state-wide reports released by the Florida Department of Economic Demographic Research. The FY21 projection is \$3.4 million (or 4%) less than revenue in FY20.
