Alex Dworzanski, the Principal at Harns Marsh Middle School, shared, "We are reaching out to the parents of students that are not being successful and inviting them back in". He continued by saying that if the parent is not comfortable due to COVID, he invites the parent to meet with him so that he can share and show the parent the safety protocols and precautions that are being used in the school setting.

He also shared that Harns Marsh Middle has a 1500 capacity. At the beginning of COVID, there were only 500 students attending face to face, now there is well over 1000 students on campus. "We are trying to fill the learning gap with some students that have not attended school since March. If they are face to face, we can control their learning."

Mr. Jerry Ford and Mr. Will Reid from Ford & Associates began with an overview of the last year, beginning with the market prior to COVID and then in March when the market began to fail.
